Directions to Champoeg

Take I-5 Exit 278 (Aurora), 7 miles south of Wilsonville. Follow signs west approximately 5 miles to the park. Allow at least 45 minutes travel time from Portland or Salem. **CARPOOLING** is strongly encouraged.

The Course

It is a beautiful park in farmland setting bordering the Willamette River. The course is basically flat on bike paths, some gravel and rollers. One loop of the course equals a 10k; 30k entrants complete 3 loops. For 30k runners needing longer than 3 hours to complete the race, please plan on using the 8am early start time. *Course closes at noon.*

Again this year: One Hammer Gel stop will be available for the 30k participants, and Hammer Heed will be at both water stops!
